Self-sustenance is vital to each and every country's survival and the COVID-19 pandemic has certainly demonstrated this. Whether it be achieving food security, improving education, making healthcare more affordable for all, and securing our nation's military readiness, it is crucial for a country to be able to develop and strengthen its operational and strategic capabilities.

Under Vision 2030, Saudi Arabia has long embarked on a journey, to grow and support its local industries. The military industries sector is undoubtedly one of the most important sectors in our drive for localization and developing our indigenous capabilities.

The inception of the General Authority for Military Industries (GAMI) in 2017 was for the purpose of driving the localization targets, enhancing transparency, empowering local and foreign investors through the licensing process, and ensuring the development and implementation of appropriate regulations. This already started to bear fruits as GAMI has created the growth of an ecosystem that has more than doubled the rate of localization from 2% in 2016 to 8% in 2020. We remain on track to drive this rate up to 50% by 2030.

For a thriving local military industries sector, we have adopted three pillars at the core of our National Military Industries Sector Strategy: military acquisition, military industry, and military research & technology. While each pillar has its own fundamental purpose, all serve the same end goal: developing the necessary ecosystem to create cost efficiency, promoting localization, developing the necessary human capital, and encouraging productive research and technology work to promote innovation and sustainability.

Through the National Military Industries Sector Strategy we have identified 11 target areas as strategic priorities, developed a research roadmap, adopted an acquisition strategy, and identified how to incentivize the enablers that will help the military industries flourish in the Kingdom.

To ensure the involvement of global defense players in this exciting process, we will be hosting a future focused World Defense Show (WDS) from March 6th to March 9th 2022, where we will be highlighting government acquisition opportunities as well as some of GAMI's frameworks. WDS will also mark a major turning point for the sector in the Kingdom, while providing investors with all the information they need on how Saudi Arabia's promising defense sector can benefit their global business expansion.

A young and thriving population, a dynamic economy, world-class research institutes – Saudi Arabia has all the right ingredients to develop itself into an advanced global military presence. With the clear guidance provided to us by Vision 2030 and the visionary leadership of The Custodian of the Two Holy Mosques King Salman bin Abdulaziz and His Royal Highness Crown Prince Mohammed bin Salman, Saudi Arabia will continue to rise as a shining star on the world stage.



The General Authority for Military Industries (GAMI) has been instrumental since its establishment in 2017 in implementing necessary strategies to transform the Kingdom's military industries sector. Through enhancing transparency, an easy permits and licensing process, and allowing 100% ownership of foreign investments, GAMI has been able to consistently increase the number of local and international companies receiving licenses to operate in a variety of different activities including military equipment, military services, military electronics, ammunition, and others.




Saudi Arabia has multiplied its localization rate in military industries from 2% in 2016 to 4% in 2017, and to 8% in 2020.

GAMI licensed companies continues to rise


The number of companies, both local and foreign, earning licenses has continued to increase **to reach 99 companies** at the end of the first half of 2021. This reflects a sustained interest in the Kingdom's military industries sector.

One key metric for the sector is the breakdown of licenses amongst local and international companies. Of the 99 companies earning licenses: 85% are local companies, while 6% are foreign companies. The remaining 9% are mixed ownership companies.




Facts and Figures

99 Companies licensed

A majority of the licenses were awarded to companies operating in the field of military manufacturing (60%), followed by military services (24%) and trading of military articles (16%).

Licenses and Establishment Permits

ESTABLISHMENT PERMITS

An establishment permit facilitates the necessary procedures to establish a company such as the company's location. It is a prerequisite to securing the necessary approvals from relevant entities, obtaining a license, and it is issued by GAMI to companies interested in manufacturing military products or providing military services

Establishment permit for military manufacturing

A permit for manufacturing military products in the Kingdom while GAMI helps in expediting approvals on the official license from relevant entities

Establishment permit for military services:

A permit for providing military services in the Kingdom, whereby GAMI facilitates obtaining the approvals for the official license from all relevant entities

LICENSES

GAMI issues Licenses for companies wishing to operate in three main activities: military manufacturing, military services, and trading of military articles.

License for military manufacturing:

License for developing, manufacturing, storing, promoting, selling, re-selling, leasing and testing military equipment

License for military services:

License for providing military services in the Kingdom, including enhancing, operating, repairing, maintenance, restoration, and other technical services.

License for trading of military articles:

License for importing military articles to Saudi Arabia for the purpose of selling, leasing, offering, promoting these articles to end users.



Key Localization Projects

L3Harris and SAMI (2021)

A joint venture to accelerate SAMI's contribution to the Kingdom's military industries sector. The venture is expected to develop local capabilities in:







Military Industries Corporation (MIC) (2020)

A project to manufacture an Armored Protected Vehicle (APV): Ad Dahna. The project aims to manufacture a multi-terrain, four-wheel drive armored vehicle that can adapt to all conditions and satisfy military specifications within the Kingdom.

Key goals of the project:

Enhance armored vehicles ecosystem

Provide trainings for operators, technicians, and trainers

GeneralElectricandSaudiAerospaceEngineering Industries(SAEI)(2020)

An agreement to train professionals in deep maintenance and repair of Early Warning Systems (EWS) and refueling of aircrafts. The joint venture will allow GE to secure inspection equipment and tools. SAEI, on the other hand, will become a licensed and certified maintenance center for these systems.

NAVANTIA and **SAMI** (2019)

A joint venture to collaborate on Combat System Integration (CSI), which will contribute to the Kingdom's military industries sector through the transfer of technology and job creation. 60% potential localization of technical capabilities through the project.

CMN Group and Zamil Offshore Services Company (2018)

Production of High Speed Interceptor (HIS) with an impressive combination of intelligence of surveillance capabilities.

Spotlight: Industrial Participation Program

- The Industrial Participation Program (IPP) was launched in 2019 as the successor of Saudi Arabia's Economic Offset Program to capitalize on existing capabilities and to generate new investments in the military industries. A cornerstone of the Kingdom's military industries sector strategy, IPP contributes greatly to enforcing policies that create huge opportunities for value creation.
- Industrial Participation is defined as an agreement between GAMI and the contractor to include local industries in delivering the supply contract, as well as building new capabilities that will contribute to reaching self-sufficiency in the targeted sectors.
